

# Missouri Valley College Immunization Requirements for ALL Students

---

## Med+Proctor – Immunization tracking

The MVC Student Health Office is using Med+Proctor to collect and verify immunization records and to complete the required TB risk assessment. You will need to have your MVC student email address to begin the process. **This is required for ALL students, including returning, freshmen, and international students.** You need to set up/register an account with Med+Proctor.

You can obtain immunization records from your infant shot record book, previous high school, health department, or your primary care physician's office.

- The Missouri Valley College Student Health Office will not accept any immunization records. ALL records must be uploaded and submitted to Med+Proctor.
- Missouri Valley College Student Health Office will NOT provide copies of immunization records at any time under any circumstance prior to Med+Proctor registration or upon your leave from Missouri Valley College. It is your responsibility to get your immunization records for Med+Proctor. We highly recommend you pay the \$12.00 one-time fee for lifetime access to your immunization records on Med+Proctor.
- All immunization submissions to Med+Proctor must be done at least 72 hours prior to check-in/arrival at Missouri Valley College. Please submit your immunization records at your earliest convenience.

## Requirements for MVC students:

- Students living in housing
- ALL students
- **Medical history form.** This is the only requirement NOT submitted and tracked by Med+Proctor. You can find it on our website. Complete this form found on the Missouri Valley College Student Health webpage.
  - **Proof of 2 MMR (measles, mumps, rubella)**– follow the link in your MVC email to set up your Med+Proctor account and upload proof of two doses of MMR vaccines. (1st dose of MMR on or after the first birthday and a second dose at least 28 days after the first dose administration date.)
  - **Tuberculosis (TB) Risk Assessment** (Annually) – in Med+Proctor you will answer questions about TB risk factors every year. If the questionnaire determines you need to show proof of a TB test, it will give you a notification, and you will need to upload documentation through Med+Proctor. TB testing must be completed before arrival to Missouri Valley College.
  - **TDAP (Tetanus, Diphtheria, Pertussis)** – One adult dose of TDAP (preferred administration at 11-12 years of age. Td or TDaP every 10 years.
  - **Meningitis (MCV4) vaccine age 16 or older** - For students living in campus housing this is a requirement. Upload proof through Med+Proctor and **allow 2-3 business days for record processing** and verification. We recommend uploading your vaccine as soon as possible.

## Have you had the correct vaccine at the correct age?

MCV4 protects against the 4 most common types of meningitis (serogroups A, C, W, Y).

- On your vaccine record, look for MCV4, Menveo, or Menactra on or after your 16<sup>th</sup> birthday.
- If you have never had the vaccine or your vaccine was prior to turning 16 - you will need an additional dose.
- There is another meningitis vaccine that protects against serogroup B: MenB, Bexsero, or Trumenba.
- MenB, Bexsero, or Trumenba vaccines are not MCV4 and do NOT meet the MVC college requirement, but are recommended.

## If you need the MCV4 vaccine, where can you get it and what do you ask for?

- Physician's office, pharmacy, local health department.
- The Health Center does NOT administer the meningitis vaccine.
- Ask for MCV4, Menveo, or Menactra.
